Voting by Absentee or Mail:

- Absentee Voting In-person: For those unable to make it to their local polling place on election
 day. General Election voting starts September 22nd and ends November 2nd. Bring your ID and
 a mask to vote at your local election board.
- Absentee voting by mail: To vote absentee by mail, fill out a request form and return it in
 person, by mail, by fax, or email to the local election board. You will have to provide the reason
 you need to vote absentee on the application. Once you receive your absentee ballot by mail,
 complete it ASAP and check to see if a notary will be required for your absentee mail-in ballot.
 Some absentee ballots in COVID-19 at-risk categories will not require a notary and will be listed
 on the request form you fill out.
- Mail in Ballots or "No-Excuse" requests: Notary Required. Due to Covid-19, you can also request a Mail-in Ballot without a reason. Fill out a request for mail-in ballot and return it in person, by mail, by fax, or email to the local election board. The election board must receive your request form for an absentee/mail-in ballot by October 21st by 5:00 pm. Once you receive the mail in ballot, complete it ASAP and make sure to NOTARIZE THE BALLOT ENVELOPE. The Ballot must be received via USPS by the local election board on November 3rd, 2020.



In Person Voting November 3rd, Tips to review before election day!



- 1. Confirm your polling place: voteroutreach.sos.mo.gov
- 2. Polls open at 6 a.m. and close at 7 p.m. If you are in line at 7 p.m. YOU CAN VOTE!
- 3. Bring proper Identification: for a list of acceptable ID, go to https://www.sos.mo.gov/showit2vote
- 4. Know your rights. Polling places are required to be accessible to all voters. Disabled voters may ask assistance from a friend, family member, or polling place worker. It never hurts to contact your local voting authority in advance to ask about voting accommodations. Visit ACLU.ORC for a list of your full voting rights.
- 5. If you feel your rights are violated in some way call the voter protection hotline at 1-866-687-8683 or the Office of Secretary of State at 1-800-669-8683 (1-800-NOW-VOTE).
